With respect to baseline, results indicate that a non-occlusive water-soluble high pressure balloon (Palacos HPU) can be considered as a useful and effective adjunctive treatment for Miller Class I gingival recessions, resulting in complete root coverage, with an optimal prognosis and a low incidence of complications and marginal bone loss. For the first time in a long time, Americans are more worried about paying for health care than about how much health care they are getting, according to a new poll from the Kaiser Family Foundation. Health care was at No. 2 among all Americans surveyed by the foundation and ahead of the economy and the U.S. international reputation. The poll is strong evidence that the Affordable Care Act has made Americans more concerned about how they are going to pay for health care, a huge problem when it comes to reining in spending and getting the health care market to work better. In the poll, 28 percent of Americans surveyed said health care was the top problem facing the country, exceeding the 25 percent of Americans who said the economy was top of mind. What is more striking is that 8 percent of those polled said the U.S.'s reputation in the world was top of mind. The Great Recession that began in December 2007, however, was still top of mind. Perhaps as the Affordable Care Act takes hold, Americans are waking up to the fact that health care spending is about to eat up half of every federal dollar that goes to health care. People are figuring that out. The public is in the midst of coming to grips with the costs of health care reform and that is forcing big changes. The law's tort reform provision is a big deal. It reduces malpractice awards in many states and might be a big win for Republicans. It's one of the few elements of the law that hasn't been stopped in the courts and has survived Republican assault in Congress. The public is very worried about that and Republicans have got to win that battle in order to advance other elements of their agenda. The cost problem is going to have to be dealt with by cutting costs, not by pointing to single payer in
