Establishment of safety and health committees by certain employers. (a) In order to promote health and safety in places of employment in this state, each employer of twenty-five or more employees in this state, including the state and any political subdivision of the state, and each employer whose rate of work related injury and illness exceeds the average incidence rate of all industries in this state, shall administer a safety and health committee in accordance with regulations adopted pursuant to subsection (b) of this section. For purposes of this subsection, incidence rate means the number of federal Occupational Safety and Health Administration recordable injuries and illnesses per one hundred full-time employees. (l) Any employer who wilfully misrepresents, through any officer, agent, employee or representative that an employee was not an employee or that an employer did not employ such employee in order to gain access to the temporary or permanent substitute employment leaves and severance pay or benefits available in such program or to conceal such facts from such employee and any third person, or to gain access to such compensation or benefits shall be fined not more than three hundred dollars for each offense.

Although Dataflux is fully functional, the Dflux.xyz website is "under construction." It will be updated regularly. Dflux.xyz operates on the Dataflux Enterprise version of Dataflux. Although both the free and enterprise versions of Dataflux work similarly, there is a few key differences between the two: The free version of Dataflux is optimized for personal use on single computers, while the enterprise version is optimized for use with multiple computers and multiple users. Additionally, the free version of Dataflux has several restrictions that are removed with the enterprise version. Some of the restrictions that the free version does not impose include: 1) A log file is saved and stored for future reference, but it is not accessible for editing.2) The free version of Dataflux does not save data to Amazon S3 and Amazon RDS.3) The free version of Dataflux does not include the shared Storage Analytics dashboard. As an additional benefit, the Dataflux Enterprise version allows for the following data types: 1) The audio files are stored in Amazon S3. The audio files are stored as a single text file that can be searched for the next keyword or can be searched for a particular keyword in text.
